2. Bids received in excess of the ABC shall be automatically rejected at bid opening.
3. The PNP FG-BAC now invites bids for the aforementioned items. Bidders should have completed, within five (5) years from the date of submission and receipt of bids a contract similar to the project. The description of an eligible bidder is contained in the Bidding Documents, particularly in Section II. Instructions to Bidders.
4. Bidding be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act". Bidding is open to all interested bidders, whether local or foreign, subject the conditions for eligibility provided in the 2016 Revised IRR of RA 9184.

5. Interested bidders may obtain further information from PNP FG-BAC Secretariat and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM during working days.
6. Interested Bidders may purchase a complete set of Bidding Documents from February 28, 2022 to March 14, 2022 at the address below and upon payment of applicable fee for the Bidding Documents, pursuant to latest Guidelines issued by the GPPB. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents on or before the submission of their bids.
7. The PNP FG-BAC will hold a Pre Bid Conference on February 28, 2022 (Monday) at 2:00 PM at PNP Forensic Group, Old Conference Room, Camp BGen Rafael T Crame, Quezon City and/or through Video Conferencing, which shall be open to prospective bidders.
8. Bids must be duly received by the FG-BAC Secretariat through manual submission at the office address indicated below on or before March 14, 2022 at 2:00 PM. Late bids shall not be accepted.
9. All Bids must accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
10. Bid opening shall be on March 14, 2022 at exactly 2:00 PM at the PNP Forensic Group, Old Conference Room, Camp BGen Rafael T Crame, Quezon City. Bids will be opened in the presence of the bidder's representatives who choose to attend the activity.

The Philippine National Police Forensic Group reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract any time prior to contract award in accordance with Section 35.6 and 41 of the 2016 Revised IRR of RA 9184, without thereby incurring any liability to the affected bidder or bidders.
