RESOLUTION NO. FG BAC-003-2022

**RECOMMENDING THE APPROVAL FOR THE CANCELLATION OF
PROCUREMENT ACTIVITIES UNDER ITB NO. 219-2021**

WHEREAS, the PNP Forensic Group (FG) has allocated Five Million Two Hundred Fifty Thousand Eight Hundred Forty-Five Pesos and 90/100 (Php5,250,845.90) for One (1) Lot Repair and Maintenance of IT Equipment and Software for Firearms Identification System (FIS), sourced from PNP Trust Receipt Fund for the month of September 2020;

WHEREAS, the Invitation Apply for Eligibility and to Bid was posted at Philippine Government Electronic Procurement System (PhilGEPS) website on December 22, 2021, at PNP website (www.pnp.gov.ph), and conspicuous places at the premises of Headquarters Philippine National Police, Camp BGen Rafael T Crame, Quezon City;

WHEREAS, the PNPFG Bids and Awards, in compliance with the republic Act 9184 and its Revised Implementing Rules and Regulations (IRR) conducted the Pre-procurement conference on December 15, 2021, Pre-bid Conference on December 28, 2021 and submission and opening of bids on January 10, 2022;

WHEREAS, FG BAC Resolution No. FG-01-2022 "BAC Resolution Declaring the 2nd Public Bidding under ITB No. 219-2021 for one (1) Lot Repair and Maintenance of IT Equipment and Software for Firearms Identification System as a "Failure of Bidding" and recommending to the Head of Procuring Entity (HoPE) the "Rebidding" of the said Project" approved by the FG HoPE on January 12, 2022;

WHEREAS, the Head, TWG for FIS Maintenance and OIC, Firearms Identification Division/End User, through memorandum dated February 4, 2022 with subject: Market Survey for FIS Maintenance, informed the FG BAC through its Chairman, that the Approved Budget for the Contract (ABC) will not be adequate for the warranty service for any of the three phases of the IBIS equipment which is estimated at Php62.4 Million based on their market survey conducted;

WHEREAS, on February 4, 2022, the PNPFG BAC convened and after thorough discussion and deliberation, the Committee agreed to recommend on the cancellation of the procurement activities under ITB-219-2021 because the ABC is not adequate for the warranty service for any of the three phases of the IBIS equipment based on current market price. Further, recommend the allocated budget be returned and request for adequate budget for the said project;

WHEREAS, Section 41 of the Republic Act 9184 and its RIRR provides that the Head of the Procuring Entity (HoPE) may opt to use the Reservation Clause by rejecting any

and all bids, declaring a failure of bidding, or not awarding the contract if lawful, valid and justifiable grounds exist;

NOW THEREFORE, the PNPFG Bids and Awards Committee **RESOLVE**, as it **HEREBY RESOLVED** to recommend to the HoPE for the Cancellation of the Procurement Activities (Bidding) of ITB No. 219-2021 pursuant to Section 41 of the Revised IRR of RA 9184 and recommend to return the allocated funds for the said project and further request for adequate funds for the repair and maintenance of FIS.
