INVITATION TO BID

1. **THE PNP FORENSIC GROUP BIDS AND AWARDS COMMITTEE (PNP FG-BAC)** through Approved General Appropriation Act FY 2022 (Maintenance and Other Operating Expenses) applies the following amount being the Approved Budget for the Contract (ABC) as follows:

2. Bids received in excess of the ABC shall be automatically rejected at bid opening.
3. The Philippine National Police Forensic Group (PNP FG) now invites bids for the above Procurement Project. Delivery of the Goods/performance services is required to be delivered within fifteen (15) calendar days from receipt of notice to proceed. Bidders should have completed within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
4. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
5. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organization country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.



6. Prospective Bidders may obtain further information from PNPPFG and inspect the Bidding Documents at the address given below during 8:00 AM to 5:00 PM.
7. A complete set of Bidding Documents from **July 19, 2022 to August 1, 2022** at the address below and upon payment of applicable fee for the Bidding Documents, pursuant to latest Guidelines issued by the GPPB. It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents on or before the submission of their bids.
8. The PNP FG-BAC will hold a Pre Bid Conference on July 19, 2022 (Tuesday) at 2:00 PM at PNP Forensic Group, Old Conference Room, Camp BGen Rafael T Crame, and Quezon City and/or through Video Conferencing, which shall be open to prospective bidders.
9. Bids must be duly received by the FG BAC Secretariat through manual submission at the office address indicated below on or before August 1, 2022 at 2:00 PM. Late bids shall not be accepted.
10. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.
11. Bid opening shall be on **August 1, 2022** at exactly 2:00 PM at the **PNP Forensic Group, Old Conference Room, Camp BGen Rafael T Crame, Quezon City**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
12. The Philippine National Police Forensic Group reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract any time prior to contract award in accordance with Section 35.6 and 41 of the 2016 Revised IRR of RA 9184, without thereby incurring any liability to the affected bidder or bidders.
