The installation list should be the same model as the bidders offer.</li><li>3. The bidder must have at least five (5) Certificates of Satisfactory Equipment Performance for each piece of histopathology equipment from local clients issued and signed by the <del>Chief Medical Technologist or Pathologist</del>.</li></ol>	<p><b>V. REQUIREMENTS FOR BIDDERS</b></p> <ol style="list-style-type: none"><li>1. The bidder must provide Certificate of Authorized Distributorship and ISO Certificate for the brand offered issued <b>to the manufacturer</b>.</li><li>2. The bidder must have a list of local installations in at least five (5) DOH-accredited hospitals <b>and/or Tertiary Diagnostic/Laboratory Facilities within the Greater Manila Area (NCR, Provinces of Rizal, Cavite, Laguna and Bulacan)</b>. The installation list should be the same model as the bidders offer.</li><li>3. The bidder must have at least five (5) Certificates of Satisfactory Equipment Performance for each piece of histopathology equipment from local clients issued and signed by the <b>End-user</b>.</li></ol>
